Dear Sir/Madam

This submission is with respect to the lack of appropriate and timely health information provided to members of the public in rural communities, in the initial days of the Hazelwood Mine Fire, particularly with respect to protection of potable water supplies.

We live approximately 30km directly due east of Morwell in the rural locality of Hallston. Our property is within a valley bounded by Yarragon/Leongatha Road, Grand Ridge Road and the Mirboo/Yarragon Road, and was directly impacted by ash and smoke from the Hazelwood Mine fire, during the initial days of the fire, whilst we were under the influence of the Easterly Wind.

The smell of burning coal was first detected on the evening of Monday 10<sup>th</sup> February. By Tuesday 11<sup>th</sup> February visibility was down to less than 500 meters, outside work was impossible due to respiratory symptoms and any fruit and vegetables picked from the garden had to be washed before being consumed due to the thick layer of ash. These conditions remained for most of the week , being intermittent thereafter depending on the wind direction.

I searched the internet intensively for information on the potential content of the ash and smoke but could find no specific information. EPA, CFA etc websites were also uninformative.

Being a rural farming property, we do not have access to town water. My concerns were such, that all down pipes were disconnected from water tanks to prevent contamination of potable (drinking) water from subsequent rain.

To the best of my knowledge,

- No health warnings were issued until the wind direction changed and Morwell South was directly impacted by smoke and ash (on or around the 16<sup>th</sup> of February).
- All health warnings were in relation to effects of smoke, ash and subsequently evacuation of those at risk.
- At no time were rural communities (not on town water) provided with any information and advice in relation to protecting their potable water supplies.
