Subject Submission to Hazelwood coal mine fire inquiry

Submission: Dear Board of Inquiry,

I am writing this submission to request that your investigation take account of the following:

Health effects: The health effects of the fire need to be 1. fully understood,

and the inquiry should recommend a separate public inquiry into the long-term

health effects on the affected population.

Fire policy: If the fire prevention policy was adequate, then the fire should

Rehabilitation bond: Rehabilitation means the mine site should be left clean

and safe. I am concerned that the very small rehabilitation bond for the Hazelwood mine will mean GDF Suez is less likely to properly rehabilitate

site, leaving a burden of possibly hundreds of millions of dollars to Victoria taxpayers.

Quality of rehabilitation: Hazelwood's mining licence requires 5. them to

"progressive rehabilitation" of the mine. I am concerned that the coal in area that should have been rehabilitated as it hadn't been mined for was still able to catch on fire. It suggests that existing rehabilitation requirements were inadequate or not enforced. Enforceable timelines: I think the Hazelwood Work Plan should enforceable timelines for rehabilitation, to ensure disused parts of the are rehabilitated and made safe as quickly as possible. Public findings: Given that this inquiry is investigating the major public health disaster, I feel it is important that the inquiry's findings be made public very shortly after the completion of your report. Since the Latrobe Shire Council was provided with a significant money to assist households with the clean up of the ash that fell through fires I feel that this spending should be audited to ensure that the money been spent wisely and has benefited the town's people to preform clean up safely, both inside and outside of their homes. The subsequent power line failure needs to be investigated alongside mine fire, it has been suggested that the lines were improperly cleaned and lead to the explosion and blackout, if this is correct then the potential further failures and further fires is greatly increased.
