

A lack of briquette supply from Morwell Briquette Factory (Energy Brix Australia) as a result of the Morwell Mine Fire caused us to bank our char retort for 22 days. As a result we incurred economic loss during this period, including:

- Manning costs \$ 64K
- Utilities \$ 20K
