Thank you for your time this morning. Following our briefing, we have prepared a standard message for you to send to parents (see attached).

Advice is also being issued to all Victorian principals that, as a consequence of today's advice from the Department of Health, any school outside of Morwell may have parents/guardians seeking temporary enrolment for their child. All schools are to welcome such families. More advice will follow on recording the movement of students and other available assistance.

If you have any families wanting to arrange home schooling, the Distance Education Centre, Victoria (DECV) is able to support you with home/school packages or can enrol students with DECV and take on the management of this process.

Materials for students in F-6 are developed in 2-week modules and for students in years 7-10 in 4-week modules.

MESSAGE FROM PRINCIPAL TO PARENTS - FOR ALL SCHOOLS OTHER THAN COMMERCIAL ROAD PRIMARY SCHOOL

The Department of Health earlier today advised people with babies and pre-school aged children, people over 65, pregnant woman and people with a pre-existing heart or lung condition who live or work closest to the mine fire in Morwell South to consider temporarily relocating until air quality has improved.

This is a precautionary action only, as the advice is that health risks have not increased.

If this affects your family, it is important for your child that you think about how they will continue their schooling.

There are a number of things you can do.

You can continue sending your child to our school as normal. Our school is already providing students with relief from the smoke and ash by rotating them to other schools for a day at a time. We are also planning for excursions out of town. These activities will continue.

You can temporarily enrol your child at another Victorian government school that is closer to where you will be temporarily living. Simply contact that school, talk with the principal about your circumstances and they will assist you in settling your child into their new school. Find a school by visiting:

You can arrange for your child to do school work at home while you are temporarily living out of Morwell. Talk to your child's teacher or principal about how to organise this.

If you also have a child at Commercial Road Primary School, the existing arrangements will stay in place. Students will continue to go to one of three schools in Moe/Newborough, with no change to the bus to and from Commercial Road to these schools.
