### Purpose

The purpose of this document is to provide an outline of the relief coordination and management arrangements in place across Victoria to ensure essential relief needs are provided to individuals and communities affected by an emergency.

This plan should be read in conjunction with:

- 1. Regional Recovery Plans
- 2. Municipal Emergency Management Plans
- 3. State Emergency Relief and Recovery Plan (Emergency Management Manual Victoria Part 4)
- 4. Emergency Relief Handbook: A Planning Guide

This plan sets out the arrangements for this Summer season. A set of appendices follow the body of this document and detail specific arrangements that are in place. These appendices contain the following information:

### **Emergency Relief Functions**

Emergency relief is the provision and coordination of essential needs to persons affected by, or involved in the management of, an emergency.

The functions of emergency relief meet the needs of affected people through the provision of:

- emergency relief centres
- emergency shelter
- food and water
- psychosocial support
- non-food items (material aid)
- Register.Find.Reunite
- first aid and primary care
- financial assistance
- animal welfare
- community information.

Relief services can be provided in a number of ways. Methods for the delivery of relief services include:

- re-supply
- outreach
- established supply points
- information points.

Incident Controllers are primarily responsible for determining the need to activate emergency relief services.

The provision of emergency relief services by affected municipal councils can be activated by the Municipal Emergency Response Coordinator (MERC), Municipal Emergency Resource Officer (MERO) or Municipal Recovery Manager (MRM).

Incident controllers should ensure that relief information for the community is available if an evacuation warning is to be issued, to ensure that the community can access relief services or centres if they require them.

### **Isolated Communities**

There will be times when the provision of relief services to the community will extend beyond the activation of a static relief centre such as the Town Hall or local Community Centre. Where communities are isolated as a result of an emergency, the functions detailed above still apply but will be provided based on identified needs. It may also become the response agencies' role to coordinate logistical support, such as the delivery of food and water.

#### Communications

During an emergency, the response agency is generally best placed to pass on initial community information relating to the activation of relief centres and general support services available to the community. Such information is integrated within emergency warnings.

The Department of Human Services (DHS) coordinate relief information at a state and regional level through mechanisms such as Victorian Emergency Relief Information Line and the whole-of-Victorian government Emergency Relief and Recovery Victoria website.

A table outlining key relief messages and dissemination channels for providing public information relating to emergency relief can be found in an Appendix to this document.

#### **Emergency Relief Coordination**

Municipal councils have responsibility for coordinating emergency relief at the local level.

DHS is responsible for emergency relief coordination at the regional and state levels. Red Cross is the support agency to DHS for relief coordination.

DHS coordinates relief during an emergency is via its Regional Emergency Operations Centre at the regional level and through its State Emergency Management Centre at the state level.

A coordinated approach to the management of resources and operations is critical to ensure the effective use of limited resources required during an emergency and to ensure operations are managed consistent with emergency management guidelines.

### **Municipal Emergency Relief Arrangements**

Municipal councils have responsibility for coordinating emergency relief at the local level. The emergency relief services and the nominated agencies responsible for delivering those services are designated in each council's Municipal Emergency Management Plan (MEMPlan).

Current lead agencies for relief functions within each municipality are listed in an Appendix.

### **Regional & State Emergency Relief Arrangements**

As the needs and consequences of an emergency increase in size and scale, resource requirements for relief services can outstrip what is available locally. Requests for supplementary resources should be made when relief agencies do not have the capacity to meet the needs of the community. The Municipal Emergency Coordination Centre can request supplementary resources for emergency relief from DHS via its Regional Emergency Operations Centre.

DHS, in consultation with the municipality, will determine the appropriate course of action, which may include requesting another agency to coordinate the provision of relief.

If supplementary resources are required, a further request will be sent to DHS' State Emergency Management Centre. The appropriate course of action will be determined at the state level, in consultation with the region, which may include requesting support from private providers and/or a request to the State Emergency Response Officer.

The following table identifies the organisations designated as having lead responsibility for the delivery of emergency relief services where local arrangements have been exceeded.

## **Financial Arrangements**

When requesting emergency relief, agencies should be familiar with the following arrangements for meeting the costs of providing emergency relief services:

- Municipal councils are responsible for meeting the cost of emergency relief measures provided to people
  affected by an emergency.
- If emergency relief is requested by a response or relief agency for its own personnel, that agency will be
  responsible for costs incurred.
- When a response agency requests emergency relief (such as catering) on behalf of a number of response agencies, the requesting agency will be responsible for costs incurred.

These arrangements apply regardless of whether emergency relief is coordinated at municipal, regional or state level.

Reimbursement of relief costs may be available under the National Disaster Relief and Recovery Arrangements administered by the Department of Treasury and Finance. Municipal councils should seek early advice regarding the availability of Natural Disaster Relief and Recovery Arrangements funding from the Department of Treasury and Finance.

### **Relief Arrangements – Emergency Incidents**

In the event of a significant emergency incident occurring, DHS may complete a Regional Incident Relief Plan to record relief service arrangements for municipalities that have been, or are likely to be, impacted. The purpose of that document is to record the level of activation of local arrangements in response to an actual emergency and the plans that are in place should an escalation be required.

### Impact Assessment

Initial impact assessment is the responsibility of Victoria Police and is carried out with the support of the emergency response agencies.

Impact assessment data is provided to the Intelligence cell at the State Control Centre. This information then informs the production of State Situation Reports that are subsequently distributed to respective agencies, including DHS. DHS will use this information, in conjunction with other intelligence, to inform relief responses.

### **Relief Agency Preparedness**

Red Cross supports DHS in the coordination of relief services. DHS coordinates relief during an emergency via its Regional Emergency Operations Centre at the regional level and through its State Emergency Management Centre at the state level.

Red Cross has an incident management team operating in preparation for the upcoming weekend and has opened the Red Cross State Emergency Operations Centre. The Red Cross State Inquiry Centre is activated if required and remains open in readiness for any significant displacement of people. The Register.Find.Reunite. portal is active online.

Victorian Council of Churches (VCC), the Salvation Army, Commonwealth Department of Human Services, Save the Children and Foodbank Victoria have stand by arrangements.

The Department of Environment and Primary Industries (DEPI) has the coordinating role and responsibility under the Victorian Emergency Animal Welfare Plan to ensure the welfare of all animals is attended to in emergencies. To ensure this occurs, DEPI currently has:

- staff on stand-by across the state to respond to animal welfare and agricultural impact assessment (if required), actively monitoring the fire situation and in liaison with fire control agencies
- additional staff capacity available should that be required, which can be activated in an appropriately timely manner
- worked with municipalities to ensure they have contingencies in their evacuation centre plans to deal with evacuated animals (both healthy and injured)
- provided media messaging about the responsibilities for, and care of, animals in fire emergencies,
- · fire recovery arrangements to oversee the care of injured wildlife, and
- developed networks with animal care agencies and personnel to assist in larger emergency responses (such as veterinarians, animal aid organisations and the Victorian Farmers Federation).

### **Register.Find.Reunite**

Register.Find.Reunite. is operational to assist reconnect and reunite families and friends where people are displaced as a result of fires. The system is open online 24 hours a day at http://redcross.org.au and by phone on 1800 727 077 for specified periods, as required.

Register.Find.Reunite. is managed by Red Cross on behalf of Victoria Police for the Commonwealth Attorney-General's Department.

### **Relief Agency Reporting and Communication**

Red Cross will coordinate reporting arrangements for relief partner agencies on behalf of DHS. During operational periods, relief agencies will be required to report daily on their operational activity, capacity and any strategic and emerging issues. This information will be collated by Red Cross and provided to DHS for inclusion in state situational reporting as required.

DHS with the support of Red Cross will coordinate operational meetings and teleconferences of relief partner agencies to ensure situational awareness and coordination of relief efforts state-wide.

#### **APPENDIX F – HHSEM Public Information – Key relief messages and channels**

The Public Information Unit (PIU) within H&HSEM's State Emergency Management Centre (SEMC) is responsible for managing, producing and coordinating a range of internal and external (public) messaging relating to DHS' relief responsibilities during an emergency event.

These activities include direct liaison with the Emergency Management Joint Public Information Committee (EMJPIC), the Victorian Emergency Communications Committee (VECC), and the communications teams at the Fire Services Commissioner, and the State Control Centre Media Unit.

The PIU also liaises with senior communication officers across the Victorian Government (including, as required, ministerial offices), and with regional and local government communications and media contacts.

As required, the PIU is responsible for planning immediate (and longer-term) WoVG relief (and recovery) public information/advertising campaigns across appropriate media/channels.

The PIU has relief (and recovery) ads prepared for radio and print if needed to immediately promote available Victorian Government relief services. The activation of such a campaign would require authorisation from the State Recovery Coordinator, together with approval from the Department of Premier and Cabinet's Strategic Communications Unit, and an appropriate budget.

The principal methods of publishing emergency relief information to the public include content updates on the *Emergency Relief and Recovery Victoria* (ERRV) website (<u>www.recovery.vic.gov.au</u>) and via the *Victorian Emergency Recovery Information Line* (VERIL) on **1300 799 232**.

The table below describes the key messages, processes and channels used by the PIU during a typical major relief incident.


