Situation Summary	The following report is focussed on the Hazelwood open cut mine fire in the Latrobe Valley and the bushfires in
	East Gippsland. The Hazelwood open cut mine fire was declared CONTROLLED on Monday 10 March. Remaining hot spots are being monitored and extinguished. The smoke from the fire remains and EPA is continuing to monitor the air quality. The Chief Health Officer has maintained the current health advice for 'people at risk' to consider relocating
	from the affected area. This advice will remain in place as EPA continues to monitor air quality data for improvements. The East Gippsland, Goongerah-Deddick Trail fire was declared CONTAINED on Monday 10 March.
	Premier Denis Napthine and Deputy Premier Peter Ryan today announced the establishment of an independent Inquiry into the Hazelwood Mine Fire, the response to and support of the Morwell and affected communities and the emergency response.

Issue	The Morwell community is experiencing levels of stress in relation to the ongoing environmental conditions.
Action Taken	DHS continues to provide respite and relocation payments and has implemented a range of community supports. Active planning is underway to transition to recovery.
