SITUATION SUMMA	ARY:
Situation Summary	There are still several ongoing fires across the state including the Mickleham Kilmore bushfire, Hazelwood – Morwell fire and East Gippsland bushfires. The fire in Hazelwood coal mine is expected to continue burning for some time.
	There are still some communities experiencing power outages as a result of the weekend's fires. DHS has received this information of customers without power from the distribution businesses and forwarded to the regions to plan the appropriate outreach activities.
	Recovery activities are ongoing in the Grampians region, and are being planned to commence in the recently affected communities across Victoria.
Known impacts	Health impacts of smoke are affecting a number of areas across the state.
	<ul> <li>Regions have also raised concerns about the psychosocial impacts of the fires, particularly in areas previously affected.</li> </ul>
	State wide 42 houses have been confirmed destroyed since Saturday.
	Victoria Police convened a meeting at 3pm to provide an overview of the initial impact summary.

SUMMARY OF ACTIV	/ITIES:
Health Command/Coordination	A Health and Human Services Liaison Officer is working in the Hazelwood Incident Control Centre for the Hazelwood Mine Fire to support the Incident Management Team. Regional Health Coordinator is participating in planning and preparation for community meetings regarding the mine fires.
	Ambulance Victoria has stood down Orange Response, except in relation to the Morwell open cut mine.
Health Protection	The Chief Health Officer has issued a Health Alert for the high level smoke warning for the Latrobe Valley.
	A low level bushfire smoke advisory has also been issued by Environment Protection Authority (EPA) for the rest of the state except the Mallee and Wimmera districts.
	The EPA has installed a mobile air quality monitor at Morwell, and has sent down an expert air quality scientist to oversee the monitoring program. The related issue is the generation of carbon monoxide (CO) at the Hazelwood coal mine fire and accordingly, steps have been put in place to increase protection for the fire fighters. While CO is not expected to cause any issue within the broader community monitoring is being undertaken.
	Air monitoring in the mine and community is occurring and will be expanded to include carbon monoxide monitoring on the boundary of the mine and throughout the community.
	The Chief Health Officer has undertaken radio interviews with ABC Gippsland about the difference between the carbon monoxide at the mine fire and the bushfire smoke which may be causing concern for the community and to emphasise health messages.
Human Services Command	Financial assistance payments officers and liaison officers have been deployed into a number of relief centres, providing emergency relief and emergency re-establishment payments. A number of inquiries have been received by members of the community who have relocated to other areas of the state and arrangements have been made for DHS staff in these localities to assess and provide payments.
	Contingency planning has identified 14 housing properties across the Hume region for interim accommodation; however there is no demand on the services at this stage.
Relief (inc Red Cross)	Relief centres are currently open at Wallan, Seymour and Delegate.
	Relief partner agencies are providing food and water, material aid and personal support. They are also on standby to provide advice on appropriate arrangements for children in relief centres. Community meetings are occurring as needed.
	Red Cross are continuing to provide first aid, and food and water to emergency service at Hazelwood Staging Ground.
Recovery	The State Crisis and Resilience '2014 Bushfires - State Recovery Coordination Team' will meet on Friday 14 February to discuss the January and February 2014 fires, including the current situation and recovery activities.
	Regional and Community Recovery Committees are occurring and being planned for in various communities.
	Nine recovery centres have been established, a number of community meetings have occurred and further meetings are planned.
	A number of impacted properties are requiring clean-up of water tanks. Households that rely on water tanks for

	drinking and sanitation are being referred to local government for assistance.
	Outreach programs and psychosocial support are being provided to affected individuals as required, in conjunction with local governments.
Communications / Public Information	A whole of Victorian Government communications plan for the Victorian Bushfires Recovery has been completed, as well as the revised Victorian Bushfires Recovery Guide to Services.
	There are ongoing updates to relief and recovery content on www.recovery.vic.gov.au, the Victorian Emergency Recovery Information Line and social media messaging. Input has been provided to a teleconference with DEPI to improve call taker scripts for Victorian Emergency Recovery Information Line.
	Information has been provided to the Emergency Management Joint Public Information Committee at a teleconference today at 4.30 pm, and a new monitoring program has commenced for social media and traditional media.
Business Continuity	Nil to report

ISSUES:	
Issue	Relief agencies have identified a high level of distress from residents, the psychosocial impact and re-traumatising of the recent bushfires from those recovering from the 2009 bushfires.
Actions taken	Relief agencies are providing psychosocial support.
Issue	Ongoing resources over the weekend and beyond for emergency work force
Actions taken	Workforce planning has identified they are able to continue with current commitment levels for the next 72 hours.  Longer term work force planning has commenced.
