1.	Weather Update
	<u>Today:</u> Dry wind change moving through. South-westerly winds, currently moving through the far east part of the state. This will have a big impact on fires in the east. Change is expected to clear the east by 1900hrs, and will be in NSW by midnight. There has been lightning at fire complexes in the last hour (at 1800hrs).
	Tomorrow: Very High FDR ratings. Mild in the south (temperatures around 20-25 degrees). No rain is expected.
	Extended Outlook: There is a possibility of rain on Friday and Saturday however this is not confirmed.
2.	Situational Awareness Current
	 Fire – Approximately a dozen areas of fire activity:_Gisborne, Mickleham, Darraweit Guim, Warrandyte, Powell Town, Morwell and the Latrobe Valley, Yarram, and a number of complexes in the East Gippsland area (inc. Glenaladale, northwest of Buchan, northwest of Orbost, Deddick, Goongerah and Club Terrace).
	East Gippsland fires are going to be long duration fire fights. The wind change reduces temperatures and increases humidity, however it will be a number of weeks until the situation there will be controlled.
	Latrobe Valley has had a number of fires. The Hernes Oak fire escaped control lines earlier today.
	There have been a number of suspected deliberately lit fires off the Strzelecki Highway which has resulted in a number of fire fronts burning in to the industrial area around Morwell. As a result, there is currently fire in the Morwell open cut, the Yallourn open cut, in plantations around Morwell, and on the north face of Hazelwood open cut.
	There is a meeting this evening with the power industry executives and emergency

services to develop a plan for the protection of critical infrastructure in that area, and a separate division of that fire is being established. There are a significant number of road closures, including the Hume Highway north of Melbourne, and a number of closures on the Princes Highway through Gippsland. Health -A couple of facilities were under threat but this has passed. AV -There is a strike team at the Craigieburn fire, and support in the community centre in Gisborne. Relief – 14 relief centres open. The one in Craigieburn is not being staffed by agency commanders at the moment. Expecting 50 out of 100 people overnight in Orbost, 100-150 in Gisborne overnight, 19 overnight in Cann River, 12 overnight in Delegate, and potential for a few more at Yarram. While these numbers are not large, people are staying which might impact on crews getting access to these areas. Police -There have been a number of reports of deaths today however there has been no confirmation, which might indicate that there have not been any at this stage. An impact assessment coordinator has been appointed. Two teams have been deployed to Mickleham fire. Local resources are sending information through for the Gisborne fire. The Arson and Explosives unit has been deployed to 7 fires today. 3 of these are worrying in terms of fire ignition source. 4 are under investigation. Vicroads -65-70 road closures. The key ones are the Princes Highway through Gippsland. The Hume has re-opened. PTV -• No services through Moe to Traralgon. Southern Cross to Bendigo services are being replaced by buses. Latrobe Valley are not able to run some of their services. **Transport** -1 service temporarily delayed at Wallan. No additional impacts from a rail freight perspective. Road diversions were adequate. Energy -Spot fires burning overburden in the mines which are not concerning at the moment, but are being monitored for risks. Fires are also threatening 2 transition lines out of Hazelwood to Rowville and to Cranbourne.

SP Ausnet had about thousand people offline due to fires in the vicinity. Some equipment has tripped at Morwell and the impact is on supply into one of the mines.
One of the lines to Moe has tripped, so they are now running on a single feed. SP Ausnet are working on this with CFA.
• PV -
 PV- 2 more parks were closed in Gippsland this afternoon (Mitchell River and Tara Range).
• Tourism -
No issues. Watching the Princes Highway closure in Gippsland.
Education –
East Gippsland will have 4 schools, 3 early childcare facilities will be closed tomorrow from 4pm. 13 bus routes servicing local schools in the area cancelled. Mickleham Primary School is being used as a staging area for CFA tomorrow and will be closed.
• <u>Future</u>
 State Controller – There is a need to get proper briefings to the Minister for
Energy.
<u>Fire Command</u>
CFA - Resources have been shifted across the state. Have assistance from NSW and MFB.
Will be resetting tonight and then will look at moving into Gippsland. NE crews held in due to the wind change but were then pushed out to fires.
5 strike teams from NSW, as well as air support over the border. Increasing resources in Latrobe Valley, including the number of pumpers. There has been some report of property losses in the Morwell Township. There is a group setting up fire fighting in the mines and increasing resources needed for that which is being planned tonight. DEPI – No issues.
MFB - No issues.
 Relief - In terms of relocation, a disability community service was relocated in Yarram. This went quite well. Evacuating aged care facilities in Morwell.
Vulnerable persons register is being utilised.
Recovery – Agriculture
Priority tomorrow will be animal welfare and then asset damage in terms of agriculture.
Operating out of DEPI Atwood for animal relief. Moving resources across to East Gippsland in Bairnsdale for access to the longer duration fires.
