- a) The risk of fire at heights needs to be assessed and control measures implemented accordingly.
- b) Communication and command need to be revisited to ensure that emergency plan, preparedness, an response are relevant to the nature of the emergency. Consideration to be given to:
- Identifying, listing and communicating major assets that must be protected first by combat agencies.
- Role and the capacity of others such as contracted services need to be revisited and inc
- 3) An action plan that addresses the above instructions is requested within 14 days of the date of this report.
