
Please note that:


We refer to your letter of 4 June 2014 (**Letter**) in respect of the information the Board requested from Mr Pole when he gave evidence at the hearing on 2 June 2014.

With respect to the three items outlined in the Letter, we respond as follows:

1. **Item 1:** The children's centre that was affected by the smoke conditions is Goodstart Early Learning Centre which is located at 252 Commercial Road.
2. **Item 2:** Mr Pole is awaiting receipt of the air monitoring data from the contracted service provider (referred to at T925, 12-13), and will produce it to the Board upon receipt.
