### **Background**

- 15. Identify the agency with primary responsibility for providing this assistance, and any other agencies involved in its delivery.

- 17. Provide your views about what worked well, what did not work well and what could have been done better in providing clean up assistance.

## **Assistance to business**

- 19. Identify the agency with primary responsibility for providing this assistance, and any other agencies involved in its delivery.
