AUSTRALIAN POWER PARTNERS B V & OTHERS is a partnership that is listed as AUSTRALIAN POWER PARTNERS B V & CISL (HAZELWOOD) PTY LIMITED & HAZELWOOD INVESTMENT COMPANY PTY LIMITED & HAZELWOOD PACIFIC PTY LTD & NATIONAL POWER AUSTRALIA INVESTMENTS LIMITED under the ABN 40924759557, also trading as IPR-GDF SUEZ HAZELWOOD.

2. OHS-0238 : Follow up on previous visit Improvement Notice Follow up - V01017400252L/111-01

I attended your workplace to follow up on an Improvement Notice V01017400252L/111-01 in relation to the Mine site's Safety Assessment for the identified Major Mining Hazard "Mine Fires" issued on the 21st of June 2012.

On the 21st of June 2012, I formed a belief that AUSTRALIAN POWER PARTNERS B V & OTHERS had not conducted a Safety Assessment for the identified Major Mining Hazard "Mine Fires" as per Occupational Health and Safety Regulations 2007 r5.3.23.

During my visit, I observed a document titled "International Power Hazelwood - Report for Major Mining Hazards Assessment, Interim Submission" dated December 2009 that states on page 19 (under the heading) "Further Work" - "Risk assessments are to be carried out for each of the scenarios for the MMHs illustrating that risk has been reduced to as low as reasonably practicable". AUSTRALIAN POWER PARTNERS B V & OTHERS Management informed me that the assessments as stated in the above mentioned document have not been finished.

In addition, a large Mine Fire occurred at this site in 2006 and in January 2012 Dredger 11 sustained major damage due to a fire, both fires had the potential to cause an incident that would cause, or pose a significant risk of causing, more than one death.

I also observed documentation (System Control Descriptions) that contains information relating to control measures as documented in the Safety Assessment 'Bow-Tie' diagram "Mine Fires". I observed that this documentation is incomplete and unfinished.

Today, I met with Management and was informed that the following actions have been taken:

The Bow - Tie diagram for the Safety Assessment for Major Mining Hazard 9 - Mine Fire (Major Fire) has now been reviewed, risk assessments for each scenario were conducted (during the review on the 4th and 5th of October 2012 - minutes obtained).

It is Management's belief that the risk associated with each scenario as documented within the Bow - Tie diagram for the Safety Assessment for Major Mining Hazard 9 - Mine Fire (Major Fire) is as low as reasonably practicable. This is documented within the minutes of the above mentioned review.

Furthermore, Management have identified "new causes" that have now also been added to the assessment and the "System Control Descriptions" that contains information relating to control measures as documented in the Safety Assessment 'Bow-Tie' diagram "Mine Fires" appears to have been completed. I observed a random selection and found them to be updated and finished

It is my belief that Improvement Notice V01017400252L/111-01 is complied with.

I met with the employer representative, and was advised there are formal representative
