1. OHS-125642-1: Follow up on previous visit
AUSTRALIAN POWER PARTNERS B V & OTHERS is a partnership that is listed as
AUSTRALIAN POWER PARTNERS B V & CISL (HAZELWOOD) PTY LIMITED &
HAZELWOOD INVESTMENT COMPANY PTY LIMITED & HAZELWOOD PACIFIC PTY
LTD & NATIONAL POWER AUSTRALIA INVESTMENTS LIMITED under the ABN
40924759557, also trading as IPR-GDF SUEZ HAZELWOOD.

2. OHS-125642-2: Follow up on previous visit I attended your site to issue a 'Letter of Warning' (dated 15th August, Ref: OHS12/03527, signed by Mr. Jarrod Edwards - Director Workplace Hazards and Hazardous Industries Group) to AUSTRALIAN POWER PARTNERS B V & OTHERS regarding a failure to notify the Authority immediately after becoming aware that an incident occurred (at Tenement MIN5004) and a failure to ensure that the incident site was left undisturbed. I communicated the contents of the letter to all present (Mr. Dietvorst, Mr. Harkins and Mr. Robinson) and obtained acknowledgment of understanding.

Management informed that they intend to communicate the contents of this letter to all site personnel and reiterate employee responsibilities re s.38 and s.39 of the Occupational Health and Safety Act 2004.

3. OHS-0274 : Follow up on previous visit Follow-up Visit - M53 Conveyor Incident

I attended your workplace to follow up on a visit I conducted on the 13th of June 2012.

On the 13th I documented that a number of actions (7) had been generated from the M53 Conveyor Incident investigation including (but not limited to) establishing clear roles for 'Responsible officers' when managing contractors and their activities, reviewing traffic management controls and traffic management procedure, reinforcing the Incident Management process to Supervision and Management and other employees (training and tool box awareness sessions to be included) - all actions had not yet to be completed as per the provided time table.

Today, Management informed that all actions have been addressed, the actions (dot points 6 and 7) re traffic management are awaiting Management sign-off. Responsible officer training is continuing (dot point 1).

4. OHS-0274-02 : Follow up on previous visit Follow-up Visit - Fire Services Incident

I attended your workplace to follow up on a visit I conducted on the 13th of June 2012.

On the 13th I documented that a number of actions (12) have been generated from the Fire Services Incident investigation including (but not limited to): conducting risk assessments, developing procedures, review and investigate use of alternative equipment, incident management training, JSA reviews and review of supervisor duties and responsibilities. The majority of these actions had yet been completed,

Today I informed Management that I will follow up on these activities during Improvement Notice V01017400241L/111-01 follow-up (re risk associated with refuelling petrol powered plant).

5. OHS-0274-03: Follow up on previous visit Follow-up Visit - Improvement Notice - Interim Directions - V01017400252L/111-02

l attended your workplace to verify that the interim directions re Improvement Notice -

V01017400252L/111-02, i.e. daily inspec ion of the water tank levels on Dredger 10 is being carried out and recorded ensuring that the water tank remains at maximum capacity.

Management informed me that the dredger 10 (D10) was not in service and connected to the fire service system (hosed-up). I observed completed Mine Control Centre (MCC) logs indicating that operators inspect water tank levels and 'call' them through to the MCC.

Whilst on site I observed the dredger 9 (D9) outage pad, Management informed me that the D9 outage is likely to commence tomorrow and last for approximately 1 week. I also observed that dredger 11 (D11) has now been relocated to the repair pad. No activities observed whilst on site, no issues observed/reported to me at the time of this visit.

If you lodge an application for internal review and you do not receive a decision within the required time frame or you receive an Internal Review decision that you are not happy with, you can then apply to Victorian Civil and Administrative Tribunal for external review within 14 days of the date the Internal Review decision or non-decision first came to your attention. Applicants seeking external review must be an eligible person.
