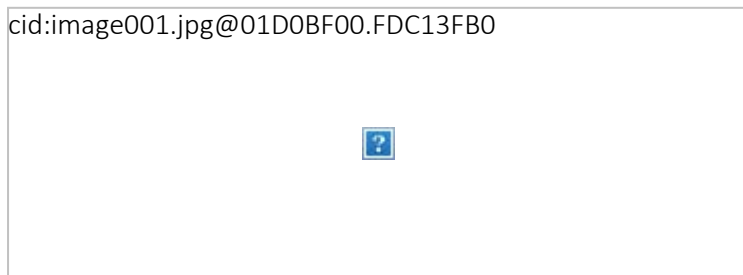

Thank you for the documents Justine,

Your letter to me was actually addressed to Adrian Barnett. I don't know if you want to resend addressed to me?

I also have a query about the list of questions for discussion and resolution at Mondays meeting.

I note that none of the questions ask about the role of exposure to air pollution from the fire in affecting mortality in the Latrobe Valley. The questions relate to mortality associations with the time period of the mine fire, with the mine fire itself, but not with smoke or air pollution from the fire. These are all different things and I believe possible mortality associations with air pollution from the fire is worthy of specific discussion. It is also my main area of expertise and where I will be best able to contribute.
