Thanks for your email.

James and I discussed your rehabilitation query last compliance visit. My understanding was that we had the same interpretation - we would expect rehabilitation to commence once mining commences of overburden suitable for use in rehabilitation, this being the commencement of mining in block 2A. The WP, section 6.5 in particular and figures 6.1 - 6.4, dictates completed rehabilitation expectations at the end of mining of specific coal blocks.

We would be concerned if, after the commencement of mining in block 2A, overburden is not used towards meeting the rehabilitation outcomes associated with the mining sequence. Dates are indicative.
