**Re: Energy Brix Australia Corporation Pty Ltd (in Administration)**

I write in relation to the recent administration of Energy Brix Australia Corporation (Energy Brix).

**EPA Licences**

Energy Brix has two licences under section 20 of the Environment Protection Act being:

**Licence number 11269** in respect to discharge of waste to air and discharge of treated water from the power station

**Licence number 4125** in respect to discharges to air from coal processing

I understand that Energy Brix is continuing to trade and operate.

Given your appointment as Administrator, the EPA would like to ensure you are aware of EPA interaction with Energy Brix and HRL Limited to date and to set up appropriate arrangements for ongoing engagement.

The priority of discussions with Energy Brix and HRL Limited has been to ensure:

- (a) Ongoing compliance with the Licences, specifically to address any environmental risk pertaining to current and proposed activities on site; and
- (b) That there is sufficient planning for site remediation in the event of cessation of the business or its sale and transfer.

**Site Inspection**

The EPA will be undertaking a site inspection of the premises at 412 Commercial Road Morwell on Thursday 5 November. I understand arrangements have been made with Mr Barry Dungey for a site representative to be present.

**Administration**

I note that the First meeting of creditors is 10.30am 9<sup>th</sup> November 2015 and I request your agreement to be present as an observer.
