# Themes and examples

- Length of study longer than 10 years; long enough to look at effects on children into adulthood; long enough to cover cancer development
- Impacts emotional; environmental; financial, including tourism; mental health; heart conditions; respiratory problems; general health effects, especially if not previously suffered; effect on unborn children; health insurance
- Clean up assistance to clean / effects of cleaning
- Mining company need to pay increased bonds; why they were allowed to continue (climate change contributor); rehabilitation of used mine areas; prevention of future fires like this
- Carbon monoxide poisoning short and long term effects; large amounts produced from a fire in the coal mine (fire authorities should have known this)
- People to be involved many / all people across the Latrobe Valley; sufficient people for accurate averages; Hazelwood workers, especially those who worked on the fire
- Help to be available for those effected financial or medical help; effect on health insurance

### One-off concerns

- Health warnings for the early stages of another incident
- Researchers to report back to the community allow others to be tested as required

- Study not just for the benefit of the effected community, but also for other communities in similar situations; study to consider Anglesea/Surf Coast residents (Alcoa; levels of SO<sub>2</sub>)
- Data collected from/by the community
- Divisions in the community; mental, emotional and social health of the community
- Free ongoing monitoring for anyone who wishes to participate
- Continued monitoring of 2.5 particles with results being published; publish results of tests on ash composition
- Heavy metal toxins effects on brain / body with build-up; effect on mental health
- Why people were told it was safe, when so many people have become sick
- Non-sustainable / carbon producing energy sources
